the Mare Owner, and Euro Horse Imports/Jennifer Delorme of 14 Voyageur Drive,
<u>Kemptville, ON, KOG 1JO, Canada</u> , hereinafter referred to as the <b>Stallion Owner</b> , on this day
of, respecting the breeding of <u>Creme de la Creme</u> , hereinafter referred to as the <b>Stallion</b> , and, hereinafter referred to as <b>Mare</b> , subject to the following Terms and Conditions:

## **TERMS AND CONDITIONS:**

- 1. The breeding fee, as stated, to be paid by the **Mare Owner** to the **Stallion Owner** is \$1,750.00 in CAD funds (or approx. \$1,450.00 in US funds, subject to exchange rate).
- 2. Booking fee of \$650.00 in CAD (or approx. \$500 in US funds, subject to exchange rate) is included within the breeding fee.
- 3. Collection fee of \$250.00 in CAD (or approx. \$225 in US funds, subject to exchange rate) is included with the first semen shipment. Subsequent shipments will incur the collection fee.
- 4. The breeding fee is due upon the signing of this agreement.
- 5. 13% HST applies to all Canadian **Purchasers**.

- 6. Written request for semen must be received by 10 a.m. on collection days. Collection days will be Monday through Friday and delivery from Monday through Saturday depending on location.
- 7. The **Mare Owner** agrees to breed, ONLY, to the **Mare** stated within this agreement.
- 8. The **Mare** shall be deemed in sound breeding condition, as determined by a certified veterinarian.
- 9. Our live foal guarantee; should the Mare fail to conceive, abort, die or not produce a "live" foal (live foal shall be defined as a foal that stands and nurses without assistance for a period of 14 days from the time of birth) then the Stallion Owner guarantees the Mare Owner shall have the right to re-breed or substitute a Mare (upon the approval and discretion of the Stallion Owner) within the current or the following breeding season only. Collection fee is applicable. Re-booking fee is applicable if breeding in the following year.
- 10. For embryo transfer breeding, we will honour the live foal guarantee on one foal. For subsequent pregnancies there will be an additional funds \$1,050.00 in CAD funds (or approx. \$750.00 in US funds, subject to exchange rate) and that does include a live foal guarantee.
- 11. Creme de la Creme is negative for EVA and WFFS.
- 12. This agreement can be used in the 2021 or 2022 season.
- 13. The parties agree that the terms and conditions stated herein set forth the entire agreement of the parties.
- 14. The agreement shall be interpreted in accordance with the laws of the province of Ontario and its validity and administration shall be governed by said laws.
- 15. The termination of this contract, if terminated by **Mare Owner**, is non-refundable in its entirety, no exceptions.
